- Application fee payment: \$500/year; \$100 commercial; \$50 Residential
- Valid copies of all necessary licenses or permits required by state or local health authorities
- Proof of Liability Insurance
- Excelsior Fire District Inspection. Contact Andy Hein: ahein@excelsiorfire.org, 952-960-1671 to set up an inspection. **The inspection must be completed 15 days prior to the event.**

Location Review and Restrictions

- Parking of mobile food vehicles shall be allowed only on private property unless otherwise allowed as part of a City festival or civic event that is licensed or sanctioned by the City Council.
- Upon receipt of a complete application for a license, the license shall be referred to the Public Works Superintendent for approval or disapproval.
- The approved operation locations shall be indicated on the license and shall include the area of the mobile food vehicle. **The license must be prominently displayed on the vehicle.**
- A full description of the requirements may be found on Chapter 10 of the City Code.
